Welcome & Public Comment	The September Board of Health meeting was called to order by Board President Nanette Shackelford at 8:31 am

Update on Board Member Appointments	Webster County Supervisor Lonnie Knehans, who was also appointed to the Board of Health, passed away 8/31/2019. A replacement will need to be appointed.  Nuckolls County commissioner James Keifer had previously reported to the Board of Health that Nuckolls county has not yet identified a public-spirited individual to take the place of Matt Blum who moved away. Michele stated she spoke with the Nuckolls County Clerk who informed her that the Nuckolls County Board of Commissioners has a person in mind, but the commissioners had not completed the formal appointment.	
Legislative Update	State Senators Dave Murman and Steve Halloran were invited to share legislative updates. Senator Murman spoke about Medicaid expansion, keeping long term care facilities open, mental health issues, property taxes, the youth rehab center in Geneva, shared a list of Interim Studies, and encouraged the Board of Health to come to him with ideas for bills. Senator Halloran discussed property tax relief (connecting it to mental health for farmers, due to weather disasters impacting their livelihood), medical cannabis/CBD oil, concerns about legalizing gambling (social costs/addiction), and teacher predator interventions.	
	Board members commented on roles of local public health in educating public on cannabis issues; the potential of taxing soft drinks and high sugar beverages and foods, just as alcohol and tobacco are taxed; insurance not covering cost of health care; and EMS squads appreciating that they now have access to epinephrine. Board members asked that the legislature prioritize funding to public health and requested that they protect the health care cash fund that was designated for public health.	:

Local Community Leader	Hastings Chief of Police Adam Story stated that the police department does more than crime and enforcement. They work with youth and are involved in mental health issues and substance abuse prevention, including marijuana and vaping. The department is also involved in pre-planning and education for mass casualty events. Chief Story spoke about the new Hemp Farm Act and law enforcement's concern about unintended consequences of this act marijuana possession is basically unenforceable now because the state lab does not have a quantitative test of THC content that would differentiate between hemp and recreational marijuana. There are also enforcement issues because drug tests cannot distinguish between detect medical and recreational marijuana. As a matter of public safety, he also stated concerns about lack of regulation for the amount of THC in CBD oil. The Hastings ordinance enforces possession rather than consumption. Alcohol used to be the primary issue with youth; now the HPD has daily marijuana cases with youth and vaping. He discussed "popcorn lung" and that without regulation, there is no quality control of the contents in vaping cocktails.  Board members commented on the recent Health Alert regarding health impacts of vaping; parents not understanding the health hazards of vaping, and SHDHD's e-cigarette policy and resolution in 2014 to promote including electronic cigarettes in tobacco-free policies.  Chief Story was excused from the meeting.	
Bi Monthly Report on 10 Essential Services from Staff	Staff members present introduced themselves and gave highlights from their programs. Jim Morgan, public health risk coordinator, talked about his work on SHDHD's Emergency Response Plan, emergency exercises to test the plan, and West Nile virus education. Dorrann Hultman, community health services coordinator, and Odeth Mendez, bilingual community health worker, spoke about the Every Woman Matters program and connecting people to colorectal cancer and breast cancer screenings in order to diagnose cancers early. Jean Korth, program assistant for chronic disease and health literacy, gave an update on the department's partnership with local libraries in all the communities for local access to health and public health information. Jessica Warner, health surveillance coordinator, discussed disease investigation and outbreak management, focusing on recent mumps cases in Nebraska and South Heartland District and highlighting the roles of public health and key consideration during outbreak situations. Brooke Wolfe, health promotions and prevention coordinator, gave an update about the Walkable Communities initiative and partnerships in Sutton. Janis Johnson, standards and performance manager, spoke about quality improvement and performance management efforts and provided an update on PHAB Accreditation Action Plan progress, which requires documentation be submitted by the December 3, 2019. Michele Bever reported that Liz Chamberlain, falls prevention coordinator and community health worker, was out of the office conducting Falls Prevention activities. Alex Stogdill, program assistant and receptionist, discussed the ways he is supporting several of the department's programs.  Board members asked about efficacy of MMR vaccine.

Communication from Executive Director	Dr. Bever referred to the executive director report included in the meeting materials. The report included a legislative update on interim study hearings for LR 116 (Nebraska Health Care Cash Fund sustainability) and LR 223 (sustainable and adequate state funding to local public health departments); a proposed federal rule change for sharing information; Surgeon General warning on the health risks associated with cannabis use on the developing brain; and a NACCHO policy statement on the use of recreational and medicinal cannabis. The report also included financial/operational updates on subaward agreements; facility/equipment needs; and funding, grants and subawards that are new/ongoing, submitted, in progress or planned. The report also included updates on PHAB accreditation process, workforce development/staffing, Community Health Improvement Plan implementation, and SHDHD strategic planning.
